

SEUSKF BOD meeting minutes, August 8, 2015 Alexandria, VA.

Meeting called to order- 9:21a.m.

Treasurer's Report- Tina Canada

The Treasurer's report was prepared (spreadsheet at end of minutes for all budget items) and read by SEUSKF Treasurer, Tina Canada. The report was accepted as read.

New Business:

Budget issues- A proposal to increase the cap for BOD reimbursement expenses for travel was discussed. The following increases were voted on:

< 200miles = \$200

200-400 miles = \$300

400-500 miles = \$400

> 500 miles = \$500

The resolution was passed unanimously. This will take effect for the next meeting beginning in January, 2016.

New budget items-National championship fund- \$6000 BOD travel expenses- \$5,200 Website fees- \$150 Regional seminars- \$600/region Mentor program- \$860 (Mentor expense detail- \$350- Central; \$160 to Western; \$350 to Southern)

New budget was passed unanimously.

Maeda sensei mentioned a need in Puerto Rico for seminar and promotion.

Update on 2017 national tournament-

Junior Nationals- A need to focus not just on winning, but on doing good kendo. A need for team players.

A request was made fro \$250 compensation to Matsumura sensei fro his role in coaching the Youth team. Request was unanimously approved.

Update on 2015 SEUSKF Championship (Craig)-

Date is set for November 7 & 8 near charlotte (Indian Trail, NC)

Location will be Carolina Courts facility. Tournament will be on Saturday November, 7. 5-6 courts will be available for the tournament. Divisions have yet to be announced.

The gym location does not have showers. There will be a lunch available for purchase but we are not supposed to eat inside of gym (there are tables for food outside of gym area but inside building.)

Banquet location is a Japanese steakhouse near tournament hotel and gym. Dinner around 8:30, exact time TBD.

There will be 2-3 courts available on Sunday for the promotion and (time permitting) godo keiko.

SEUSKF and AUSKF dues



At the start of the August 2014 SEUSKF Board of Directors meeting, the SEUSKF began hosting a leadership and kendo seminar. This is only the second seminar. Another will be hosted in the summer of 2016 and will be an annual event.

- The AUSKF will only accept dues from the regional federation representative (i.e. SEUSKF Treasurer). Dojos and dojo members cannot individually pay only the AUSKF fee or try to pay fees directly to the AUSKF.
- All individuals MUST be a member of a dojo and all dojos MUST be a member of a regional federation.
- Any changes to dojo roster or inquiries into insurance claims MUST be submitted to the regional federation representative, who will contact the AUSKF. The AUSKF will not make any changes or fulfill any requests for individual members or dojos unless it has been made by the proper regional federation representative.

Rules/Benefits

Rules

- Dues paid annually by deadline
 - \$70 adults/\$50 children
- Waiver

Benefits

- AUSKF Insurance
- Eligibility for AUSKF Championships
 - 3 years prior for Mens/Womens
- Eligibility for shinsa exam
- Discount for events
- The AUSKF requires that all dues are paid annually and on time and that all members have a signed waiver that is to be maintained by each regional federation.
- Each dojo should keep a copy of the waivers that are signed and submitted to the regional federation representative.
- The AUSKF Insurance coverage is only in effect during the period that the member has submitted and paid for dues.
- All members of the regional federation Mens and Womens team to the AUSKF National Championships, must be a dues paid member for the two years prior to and the year of the Championship.
- Members are only eligible for a shinsa exam during the period that the member has submitted and paid for dues. The AUSKF can and will revoke a rank earned during a shinsa if the member in question was not a dues paid member at the time of the shinsa exam.
- Events are allowed to charge extra to non-regional federation members as well as non-AUSKF members. Some event facilities now require that all participants be covered by insurance in order to participate; any and all dues paid members are covered by the AUSKF liability insurance.

New effective date

1.01.01: "The effective date of annual membership fees paid by March 31 of each calendar year is from April 1 through March 31 of the next calendar year."

1.01.02: "Collection of the annual membership fee after April 1 in each calendar year is effective the month and day collected by member through March 31 of the next calendar year, regardless of the month of collection, up to and including March."

AUSKF Policies and Procedures, Amended November 8-9, 2015

- Previously, the effective date was from January 1st through December 31st.
- As of 2015, the new effective date will be from April 1st through March 31st.

April 1, 2015 to March 31, 2016

April 1, 2016 to March 31, 2017

- Those who have paid dues for 2015 are eligible for shinsa exams up until March 31, 2016 when the effective date expires.
- Members must renew for the 2016 dues period in order to be eligible for any shinsa exams between April 1, 2016 and March 31, 2017.
- Any new members who submit new dues from January 2016 to March 2016, will have their dues expire in March 31, 2016. They must also pay for new dues for the effective period of April 1, 2016 through March 31, 2017.

Act accordingly to make sure all annual dues are:

ACT

Accurate:

Accurately fill out all forms and form fields:

- Full Name (as seen on menjo)
- Date of Birth
- Gender (M/F)
- AUSKF ID number
- Rank

- Make sure there are no typos in a person's name.
- Whatever name they register under will be the name that shows on their menjo.
- A full list of names of current paid members as they appear registered with the AUSKF can be downloaded from the SEUSKF website.

<u>Quick Tip:</u> If there are any name changes, please make sure that the SEUSKF Treasurer is notified so that they can forward the changes to the AUSKF.

<u>AC</u>T

Complete:

Make sure the submission of dues is complete:

- Roster of dojo members
- Check/money order for full payment
- Signed waivers for all members

- Ensure that all members who intend to try-out for the regional federation have paid their dues.
- Ensure that all members who intend to take a shinsa within the year have paid their dues.
- Ensure that all fees are correct and check amount is correct.
- Ensure that a full roster, a check, and any signed waivers are included in the dues packet.

<u>Quick Tip:</u> Use the excel spreadsheet to tabulate the correct fees and double-check the spreadsheet to ensure all members are correctly registered.

<u>ACT</u>


Timely:

Ensure that dues packet is completed and mailed out prior to the deadline provided in the dues registration packet.

Reminder: Dues are accepted throughout the year, but must be <u>in my hands</u> at least 30 days prior to an event.

- At least a two weeks prior to the dues packet deadline, mail out the completed dues packet to provide a safe buffer.
- New member dues must be in at least 30 days prior to an event or shinsa.
- If dues are not submitted by the dues packet deadline, the dojo will receive a minimum of <u>two</u> written warnings. If after the two warnings have been issued and the dues packet has not been submitted to the SEUSKF Treasurer, then the dojo will receive a penalty.
- The penalty for not submitting dues on time by the scheduled deadine is for ALL
 members of that dojo to be ineligible to participate in a shinsa or event for a minimum
 of 90 days after the dues have been received by the SEUSKF Treasurer. The date for
 when the penalty period is not established until after the SEUSKF Treasurer receives the
 delinquent dues. Only after the penalty period has expired may the members of the
 delinquent dojo participate in a shinsa or event.

<u>Quick Tip:</u> Email the roster of new/renewed members to the SEUSKF Treasurer prior to mailing the dues packet so that the Treasurer is aware that dues are on their way.



Make sure that ALL dojo members are aware of these rules and regulations.

Contact the SEUSKF Treasurer with any questions or concerns.
