#### **Meeting Minutes**

#### Secretary's Report-

The minutes from the previous meeting on Aug-3-2019 were read. Minutes as read were passed unanimously.

We had a small discussion not on agenda with a short update by Maeda and talk of a potential seminar. Koryo (VA) was thought to be a possible site as host. It was discussed that we would like to keep fees to a minimum but that the host dojo might need to charge a small fee to cover costs.

There was also a short discussion of team members and costs. In addition to the support directly from the SEUSKF it is thought that each dojo should try to get support for their members that are on the team. We are trying to defray participant's costs to themselves and family to a minimum and support by the home dojo of each participant would be helpful if available.

#### Treasurer's Report-

It was noted that AUSKF dues would be past due after March 15. Tina Canada would send out dues notices to all members.

A waiver that includes SEUSKF as well as home dojo should be done and then posted to SEUSKF web page for members. This would be in addition to insurance coverage by AUSKF and would also cover in times when insurance coverage might lapse at renewals.

#### **Old Business:**

#### **BOD** numbers

Previously we had discussed whether it was advisable to increase the BOD numbers form 9 members to a higher number to increase membership population and to spread workflow for the board across more people. It was decided that at this time that idea would be tabled and we would not pursue it right now. However we did discuss the need for more individuals in particular projects. It was decided that it would be reasonable for the board to create non-board member committees with individuals from the SEUSKF membership to hold positions, even advisory committees. This could potentially be helpful for events and SEUSKF team needs and the like. So this is an open idea that the Board may enact as needed.
